

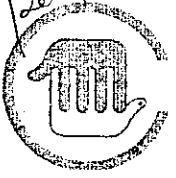

VACANCY CIRCULAR

The Central Zoo Authority (CZA) is a statutory autonomous body under the administrative control of the Ministry of Environment & Forests, Govt. of India. The CZA was established in February, 1992 with the objectives to enforce minimum standards and norms for upkeep and health care of animals in Indian Zoos, to provide them technical and other assistance for improvement and to restrain mushrooming of unplanned and ill-conceived Zoos that were cropping up as adjuncts to public parks, industrial complexes and waysides.

Application is invited in the prescribed proforma for the post of **Deputy Inspector General (HQ)** New Delhi in the Central Zoo Authority on deputation basis, as per details give below:-

It is requested that application in the prescribed proforma (**Annexure I**) duly signed by the applicant alongwith Annual Confidential Reports for the preceding five years' duly attested by a Gazetted Officer alongwith vigilance clearance, integrity certificate, statement of minor/major penalty, if any, imposed on the officer during the service may be sent through proper channel for the post of **Deputy Inspector General** to the Member Secretary, Central Zoo Authority, B-1 Wing, 6th Floor, Pt. Deendayal Antyodaya Bhawan, CGO Complex, Lodhi Road, New Delhi - 110 003 latest by **16.02.2019**.

General instruction

1. The officers/officials selected may be posted at CZA Head Quarter New Delhi.
2. The name of the post applied for may be written in bold letters on the top of the envelope and the bio-data.
3. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/Department of Central/State Government shall not ordinarily exceed **five years**.
4. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of the receipt of applications.
5. The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationist shall not be eligible for consideration for appointment by promotion.
6. The deputation rules, regulations and provisions as issued from time to time by DoPT shall be applicable.
7. Applications received after the last date and incomplete applications will not be considered.


