Sub: Three Week Training Course of Forest Officers in Wildlife Management at Wildlife Institute of India, Dehradun-regarding.

Sir,

As you are aware that the Ministry of Environment, Forests & Climate Change (MoEF&CC), Government of India have been sponsoring one/two-week refresher training courses for the IFS officers on various topics/themes related to forestry, wildlife and environment management & administration and other related topics for management in government, organized by premier institutions/organizations in the country.

2. For the above purpose, MoEF&CC has continuously been locating and empaneling renowned institutions all over the country capable of undertaking courses on diverse subjects to senior in-service IFS officers. Wildlife Institute of India (WII), Dehradun has conducted **one three-week training program** for IFS officers on "Wildlife Management" during 16th February, 2015 to 6th March, 2015 for those who have not undergone 9 months diploma course at WII in the past.

3. **The next three week course will be organised tentatively from 19th October, 2015 to 6th November, 2015.** The course content include Population Ecology, Wildlife Health Management, Immobilization of Wild Animals, Management of Wetlands Captive Management, Ecotourism, Humann Wildlife Conflict, Wildlife forensics, Landscape Conservation, Eco development of Communities etc. The course will be useful for management of wildlife both inside & outside National parks and sanctuaries. The officers who have not undergone 9 months diploma course in the past are eligible.

4. In view of the above, you are requested to kindly nominate IFS Officers for the above mentioned training and communicate to the MoEF&CC **latest by 7th June, 2015** so that nominations can be finalised for the said training.
