3. A path from Calicut Gudalur public road in North westernly direction through plantation 1848 of Aruvacode to the Chaliar river.

**Private:** A path following right of way (No. 1) public from where it crosses Chalia to its reaching plantation to Vaiyilkunnu padam in Edacode.

2. A path from western corner of Arivillicavu plantation 1852, through that plantation in a westerly direction to Pathiripatu poyil in the same plantation.
