Whereas the industrial dispute between the employers in the Coir Factories in the Alleppey area represented by (1) The Travancore Coir Mats and Matting Manufacturers' Association, Alleppey, and (2) The Indian Coir Manufacturers and Shippers Association, Alleppey, and their workmen employed in the Coir Factories in the Alleppey area represented by (1) The Travancore Coir Factory Workers' Union, Alleppey, and (2) The Ambalapuzha-Sherattai Coir Vyavastha Thozhilali Union, Alleppey had been referred by Government by their Order No. R. O. C. 3114/49/Lab. dated 10th June 1949 to the Industrial Tribunal, Travancore under Section 10 (1) (c) of the Travancore Industrial Disputes Act, 1124 and whereas the said dispute now falls within the jurisdiction of the Industrial Tribunal, Alleppey;

Now therefore, in exercise of the powers conferred on them by Section 10 (4), Government are pleased to transfer the said dispute to the Industrial Tribunal, Alleppey, who will proceed with the adjudication from the stage to which it has reached.

With the sanction of His Highness the Raj Pramukh of the Travancore-Cochin State it is hereby declared under Section 18 of the Travancore Forest Act II of 1068, as subsequently amended, and as continued in force by the United State of Travancore and Cochin Administration and Application of Laws Act VI of 1125, that from and after the date of publication of this Notification in the Gazette, the tract specified in the subjoined schedule shall be a Reserved Forest.

Cairns have been erected along the boundaries of the Reserve and a correct description of the boundaries with reference to the cairns is hereto appended for the information of the public.

Extent of area	116.72 acres.

Situation. The reserve is situated north of Ranni Reserved forest, east of Arudai Fuel Reserve, South of Kottayam-Kumili Road and West of Pambanar Malai and comprises Survey Nos. 324 and 1166 of the Peermade Pakuthy.

BOUNDARIES.

North. Starting from Cairn No. 1 at the North West corner of the reserve at the Theodolite station at

the trijunction of survey Nos. 327, 326, 1166 of the Peermade Pakuthy, the line goes nearly South East along the boundary between survey Nos. 1166 and 1167 for a distance of about 1½ chains to C. No. 2 at a Theodolite Station thence it runs nearly North East along the boundary between the aforesaid survey Nos. for a distance of about 4 chains to C. No. 3 thence nearly east, South-east along the same boundary for a distance of about 5½ chains passing C. No. 4 to C. No. 5 thence nearly South-east along the same boundary for a distance of about 9½ chains passing C. Nos. 6 to 8 to C. No. 9 at the Theodolite Station at the Trijunction of survey Nos. 1166, 1167 and 438, thence nearly South-west along the boundary between survey Nos. 1166 and 438 to a distance of about 4½ chains to C. No. 10; thence nearly South-east along the same boundary for a distance of about 2½ chains to C. No. 11; thence in the same direction but more to the east along the same boundary for a distance of about 14½ chains passing C. Nos. 12 and 13 to C. No. 14 at the Theodolite Station; at the trijunction of survey Nos. 1166, 441 and 438 of the Peermade Pakuthy at the North-east corner of the reserve

East. From the above point the line goes nearly South-west along the boundary between survey Nos. 1166 and 441 and 324 of the above pakuthy for a distance of about 55½ chains passing C. Nos. 16 to 24 to C. No. 25 at the Theodolite Station at the South-east corner of the reserve and at the trijunction of the survey Nos. 441, 324 and 1133 of the Peermade pakuthy.

South. Thence the line runs nearly west north-west along the boundary between survey Nos. 1133 and 324 of the above pakuthy for a distance of about 13½ chains passing cairn Nos. 26 to 31 to C. No. 32 at the Theodolite station at the South west corner of the reserve.

West. Thence the line runs more or less north along the boundary between survey numbers 1133 and 324 of the above pakuthy for distance of about 7½ chains passing cairn Nos. 33 to 35 to Cairn No. 36 at a theodolite station; thence nearly north-east along the same boundary and the boundary between the survey Nos. 1133 and 1166 for a distance of about 9½ chains passing cairn Nos. 37 to 40 to cairn No. 41 at the trijunction of survey numbers 1123, 330 and 1166, thence nearly south-east for about 1½ chains along the boundary between survey Nos. 330 and 1166 to cairn No. 42, thence nearly north-east along the same boundary for about 2½ chains to cairn No. 43 at the trijunction of survey Nos. 330, 328 and 1166, thence nearly east, north-east along the boundary between survey Nos. 328 and 1166 for about 2½ chains to cairn No. 44 thence, nearly north-east along the same boundary for a distance of about 35½ chains passing cairn Nos. 45 to 55 to cairn No. 56 at a theodolite station at the trijunction of survey Nos. 327, 328 and 1166, thence in the same direction along the boundary between the survey Nos. 327 and 1166 for about 2 chains to cairn No. 1, the starting point at the north-west corner of the reserve.

Remarks: There are no public or private rights within the Reserve.
