**IFS – CREATION OF EX-CADRE POST, TRANSFER & POSTINGS OF IFS OFFICERS -
ORDERS ISSUED.**

ORDER

Sanction is accorded for the creation of an ex-cadre post of Additional Principal Chief Conservator of Forests (FMIS) in the pay scale of level 15 in the Pay Matrix Table (Pay Range Rs.1,82,200 - Rs.2,24,100) for a period of one year from the date of this order. The nature and status of the post of Additional Principal Chief Conservator of Forests (FMIS) is equated with the cadre post of Additional Principal Chief Conservator of Forests (Administration) in the vertical column 15 of Pay Matrix Table (Pay Range Rs.1,82,200 - Rs.2,24,100) as per IFS (Pay) Rules 2016.

2. The following transfer and posting of IFS officers and charge arrangement to the IFS posts are ordered with immediate effect.

The service of Shri.K.Karthikeyan IFS (KL:2008), Divisional Forest Officer, Palakkad is placed at the disposal of Labour & Skills Department in the pay scale of level 11 in the Pay Matrix table for being appointed as Managing Director, Rehabilitation Plantation Ltd. on deputation basis. The nature and status of the post of Managing Director, Rehabilitation Plantation Ltd is equated with the cadre post of Deputy Conservator of Forests (Wild Life) in the vertical column 11 of Pay Matrix Table (Pay Range Rs.67,700 - Rs.2,08,700) as per IFS (Pay) Rules 2016.
