ORDER

Based on the recommendation of the Civil Service Board meeting held on 21.03.2017, transfer and postings of IFS officers at Principal Chief Conservator of Forest & Additional Principal Chief Conservator of Forest level has been ordered vide Government order read as 3rd paper above with immediate effect. Vide letter read as 4th paper above modifications have been suggested by the Principal Chief Conservator of Forest & Head of Forest Force in the said Government Order in order to restrict the total posts of Principal Chief Conservator of Forests within the present limit.

2. Government have examined the matter in detail and are pleased to modify the Government Order read as 3rd paper above, as follows:-

- i) The ex-cadre post of Principal Chief Conservator of Forest (Working Plan & Research) & Custodian, EFL created as per the Government Order read as 1st paper above is discontinued and instead of that an ex-cadre post of Principal Chief Conservator of Forest (Forests Land & Resources) in the Scale of Pay of HAG+ Scale at Level 16 in the Pay Matrix Table (Pay Range Rs. 2,05,400 – 2,24,400) in the grade of Principal Chief Conservator of Forest under Rule 11 of IFS (Pay) Rules, 2007 is created. Shri. P.K.Kesavan IFS (KL:1986) is posted as Principal Chief Conservator of Forest (Forest, Land & Resources). He will also look after the functioning of Special Afforestation & Nodal Officer, CAMPA and function as Custodian, EFL.
- ii) The post of Additional Principal Chief Conservator of Forests (Forest, Land & Resources) is kept in abeyance.
- iii) Chief Conservator of Forest (Working Plan & Research) presently reporting to Principal Chief Conservator of Forest (Working Plan & Research) will report to Principal Chief Conservator of Forest (Social Forestry), Thiruvananthapuram since the post of Principal Chief Conservator of Forest (Working Plan & Research) is discontinued.

3. The Government Order read as 3rd paper above stands modified to the above extent.
