The Kerala Public Service Commission had selected and advised Sri Subair N, Sri. Abju K. Arun, Sri. Arun R.C, Smt. Remya S, vide letter read as 1st, 2nd, 3rd & 4th above respectively for appointment as Range Forest Officers in the Kerala Forest Department under Direct Recruitment earmarked for those who possess a Degree in Forestry, Science or Engineering. Government vide letter read as 5th had issued direction to appoint Sri. A. Vijin Dev for the post of Range Forest officer under Direct Recruitment quota earmarked for those who possess a degree in Science or Engineering.

The above five candidates were temporarily appointed as Range Forest Officers and deputed for 18 months certificate course of Range Forest Officers during 2017 - 2018 at Tamil Nadu Forest Academy, R.S.Puram, Coimbatore (T). After successful completion of 18 months certificate course of Range Forest Officers, they were deputed for practical training for one year in the Department on 20.08.2018 vide order read as 7th cited.

In order to give suitable posting to the Range Forest Officers who had successfully completed both the Institutional Training and Practical Training in the Forest Department and to fill up the existing vacancies of Range Forest Officers and due to administrative exigencies the following posting order is issued with immediate effect.
