The Adhoc Departmental Promotion Committee (Lower) held on 01-11-2016 has approved the revised select list of of Junior Superintendents for promotion as Senior Superintendents in Kerala Forests & Wildlife Department for the year 2016 and the same has been published in the extra ordinary gazette No. 256, dated: 30-11-2016 in Notification No. D3-40011/2016/FHQ, dated: 03-11-2016 of the Principal Chief Conservator of Forests (Wildlife) & Chief Wildlife Warden, Kerala.

On 30-11-2016, Smt. Selinamma P.J, Senior Superintendent, Office of the Divisional Forest Officer, Kothamangalam Division has been retired from service on superannuation. Smt.
